Do Not Sell or Share My Personal Information

This page allows you to exercise your privacy rights and manage how SwifTrade LLC (“SwifTrade,” “we,” “us,” or “our”) collects, uses, shares, and discloses your personal information. The choices available to you may depend on the state in which you reside and on whether you have an account with us. For complete information about how we handle your personal information, please review our Privacy Notice and Cookie Policy.

1. Opt Out of Sale or Sharing of Personal Information

Under the California Consumer Privacy Act (“CCPA”), as amended by the California Privacy Rights Act, and similar laws in Colorado, Connecticut, Delaware, Indiana, Iowa, Kentucky, Maryland, Minnesota, Montana, Nebraska, Nevada, New Hampshire, New Jersey, Oregon, Rhode Island, Tennessee, Texas, Utah, Virginia, and Washington, you have the right to opt out of the “sale” or “sharing” of your personal information for cross-context behavioral advertising or other commercial purposes.

SwifTrade does not sell personal information for monetary consideration. However, our use of advertising and analytics cookies may constitute “sharing” of personal information for cross-context behavioral advertising under applicable state privacy laws. The categories of personal information that may be “shared” in this manner include identifiers (such as cookie IDs, IP addresses, and device identifiers), internet or other electronic network activity information, and inferences derived from such information.

How to Opt Out

You can opt out of such sharing in any of the following ways:

- **Through Our Cookie Settings** — Click the “Cookie Settings” link in the footer of any page on our website to open the cookie preference center, then disable the “Marketing & Advertising” and “Analytics & Performance” categories.
- **Via Global Privacy Control (GPC)** — Our Services are designed to recognize and honor Global Privacy Control (GPC) signals sent by supported browsers. Enabling GPC on your browser will be treated as a valid opt-out request for the device and browser on which it is enabled. - **By Email** — Submit a request by emailing admin@swiftradellc.com with the subject line “Do Not Sell or Share My Personal Information.” Please include your full name, business name (if applicable), email address associated with your account (if any), and the state in which you reside. We will process your request within the timeframe required by applicable law.
- **By Mail** — Submit a request by writing to: SwifTrade LLC, Attn: Privacy Officer, 940 N Belt Line Rd, Suite 135, Irving, Texas 75061.

Please note that opt-out preferences submitted through our Cookie Settings or via GPC are stored on a per-device, per-browser basis. You may need to repeat the opt-out process if you clear your

cookies, switch browsers, or use a different device. If you have an account with us and submit your opt-out request by email or mail, we will honor your preference across all devices linked to your account.

2. Limit Use of Sensitive Personal Information

Under the CCPA and certain other state privacy laws, you have the right to limit the use of your sensitive personal information to purposes specifically permitted by law (such as providing the Services you request, processing payments, verifying identity, preventing fraud, and complying with law).

SwiftTrade uses sensitive personal information (such as government-issued business identifiers, payment-card information, and financial-account information) only for these permitted purposes. We do not use sensitive personal information to infer characteristics about you, for targeted advertising, or for any other purpose that would trigger the right to limit. For that reason, we do not currently offer a separate opt-out mechanism for the use of sensitive personal information.

3. Other Privacy Rights

Depending on the state in which you reside, you may also have the following rights with respect to personal information SwiftTrade has collected about you:

- **Right to Know / Access** — Request access to and a portable copy of the personal information we have collected about you.
- **Right to Correct** — Request correction of inaccurate personal information.
- **Right to Delete** — Request deletion of personal information we have collected about you, subject to certain legal exceptions (including retention required by law, fraud prevention, completion of pending transactions, and defense of legal claims).
- **Right to Non-Discrimination** — Receive equal service and pricing regardless of whether you exercise your privacy rights.
- **Right to Appeal** — Appeal a denial of any of the above requests.

How to Submit a Request

To exercise any of these rights, please email us at admin@swiftradelc.com with the subject line “Privacy Rights Request” and include:

- your full name and business name (if applicable);
- the email address associated with your SwiftTrade account (if any);
- the state in which you reside;
- the specific right you are exercising (access, correction, deletion, etc.); and
- any additional details that will help us respond to your request.

We will respond to your request within the timeframe required by applicable law (typically 45 days, with a possible extension of 45 additional days where reasonably necessary). We will need to verify your identity (and, if applicable, the authority of any authorized agent acting on your behalf) before processing your request, and we may request additional information for that purpose. Information you provide for verification will be used solely to verify your identity and process your request.

4. Authorized Agent Requests

You may authorize another person or business (an “authorized agent”) to submit a privacy request on your behalf. To do so, the authorized agent must provide us with: (a) written permission from you authorizing the agent to act on your behalf; and (b) verification of the agent’s identity. We may also require you to verify your own identity directly with us or to confirm that you provided the agent permission to submit the request.

5. California “Shine the Light” Request

California Civil Code § 1798.83 (the “Shine the Light” law) permits California residents who have an established business relationship with SwifTrade to request information about our disclosures of personal information to third parties for those third parties’ direct marketing purposes during the immediately preceding calendar year. To make such a request, please email admin@swiftradelc.com with the subject line “Shine the Light Request.”

6. Marketing Communications

To opt out of receiving marketing emails from SwifTrade, click the “unsubscribe” link in any marketing email you receive from us, adjust your email preferences in your account settings, or contact us at admin@swiftradelc.com with the subject line “Unsubscribe.” Even after opting out of marketing communications, we may continue to send you transactional and account-related communications (such as order confirmations, shipping notifications, invoices, and account-security alerts).

To opt out of SMS or text messages, reply “STOP” to any message you receive from us. Standard message and data rates may apply.
